THE FEE FOR ADOPTION SHALL BE TEN DOLLARS. THE ADOPTER OF ANY CAT OR DOG MUST HAVE THE ANIMAL VACCINATED AND OBTAIN A CITY REGISTRATION TAG WITHIN TEN (10) DAYS OF THE ADOPTION. THE ADOPTER SHALL SEND PROOF OF RABIES AND/OR CITY REGISTRATION TAG NUMBERS, DATE AND VET'S NAME AND PHONE NUMBER TO ANIMAL CONTROL.

**AFTER THE REQUIRED TEN (10) DAYS, CITATIONS WILL BE ISSUED!**

**STATE LAW REQUIRES** ALL DOGS AND CATS FOUR (4) MONTHS OF AGE TO BE VACCINATED FOR RABIES BY A LICENSSED VETERINARIAN.

UNDER **CHAPTER 828 OF THE HEALTH AND SAFETY CODE**, ALL ANIMALS ADOPTED MUST BE STERILIZED (SPAYED OR NEUTERED) WITHIN THIRTY (30) DAYS OF THE ADOPTION.

**FAILURE TO COMPLETE THIS STERILIZATION IS A CRIMINAL OFFENSE PUNISHABLE AS A CLASS C MISDEMEANOR!**
